
Documents

All users can now see Document Change Comments

The Change Comments field was previously not viewable by all system users. This has now been changed so that all users can see the details entered in this field when viewing a new revision. This will aid users in figuring out what has changed between versions.

Restrict changing of Issue Date

You can now prevent the Issue Date of a document being edited if desired. This is set as a variable against a Document type as shown in the image below.

Audit

Associated Items against an Audit can now be assessed against Planned and Covered

Items within the Associated Items tab now have a tick box next to them and have two new columns called Planned and Covered. These columns are to allow an Auditor to indicate whether an Associated Item or Scope item has been looked at as part of the Audit. A Coverage bar also automatically updates and provides a percentage based on selections.

Training

Training Records can now be cancelled

A training record can now be cancelled. This will allow records created in error, or perhaps for employees that missed or did not attend a training event, to be cancelled and therefore more accurately reflect what training an employee has been involved with.

When cancelling a course, a reason is required. This is a new drop down list that the customer can populate themselves.

Retraining required Notification and Reminder enhancement

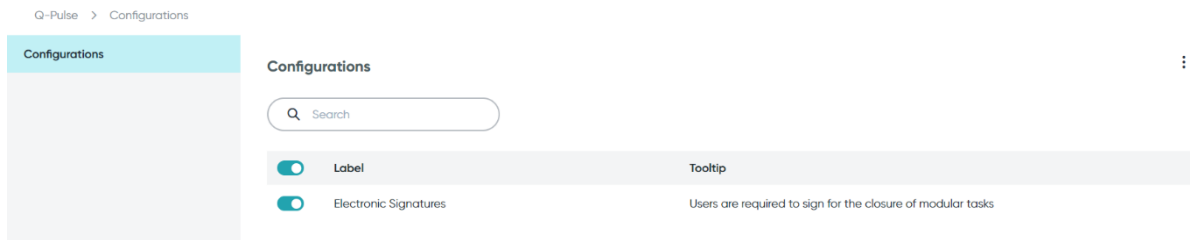
Notifications and Reminders for when retraining is required for a training event can now be set independently from training confirmation notifications and reminders.

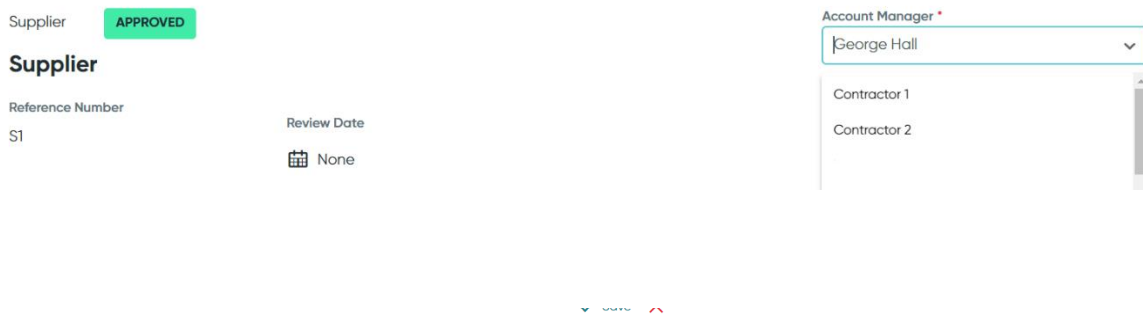

The Account Manager field and Reference Number have now been set as Mandatory fields.

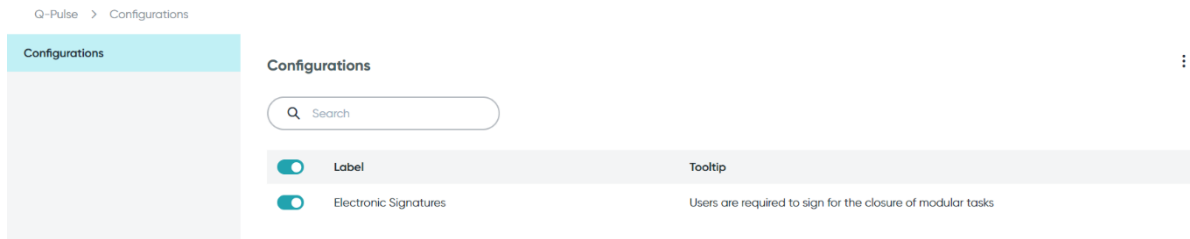

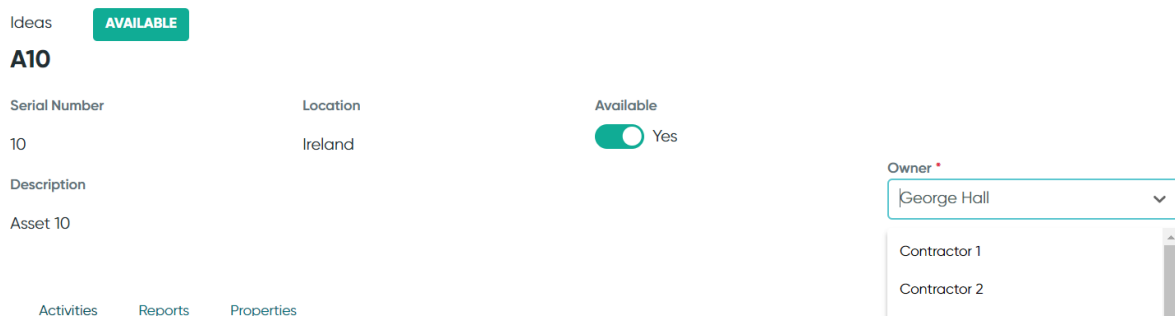


System Actor now included within Notification Emails

Notification emails have had a small enhancement added to them. These will now display a reason as to why you are receiving an email. For example, it may say you are receiving this as you are an Asset Owner or an Activity Owner.

The Asset Owner field has now been set as a Mandatory field.

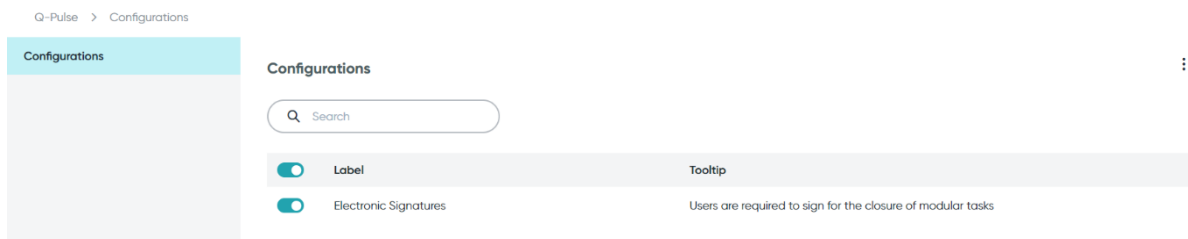


Risk

Formula Assessment enhancement - Notifications

Email notifications will now display the type of Assessment used for working out the score as well as now catering for results produced using Formulaic Assessments.

Formula Assessment enhancement – Display Scores

When creating or using a Formula based assessment, it is now possible for the score to be shown on the banding rather than the banding label.

Bulk User Permission Assignment (Essentials)

User permissions, within the Essentials part of Q-Pulse Cloud, can now be assigned in a bulk fashion to multiple users. Previously, this was performed on an individual basis with each users record requiring accessing and permissions set. This can now be done on a much larger scale.
